RESOLUTION NO. <u>09-188</u> Series of 2020

RECOMMENDING THE FAILURE OF BIDDING THROUGH SECTION 35.1 OF THE UPDATED 2016 REVISED IRR OF RA 9184 FOR THE SUPPLY AND DELIVERY OF DIGITAL VOICE RECORDER

WHEREAS, the Commission on Human Rights (CHR), through the **GAO-GSD** will procure the the Supply and Delivery of Digital Voice Recorder with an Approved Budget for the Contract (ABC) of Eighty Thousand Pesos (PhP 50,000.00);

WHEREAS, said procurement project shall be sourced from the 2020 GOJUST Fund pursuant to the CHR Indicative Annual Procurement Plan (APP) for CY 2020;

WHEREAS, the Special Bids and Awards Committee for Foreign Assisted Projects (SBAC-FAPs) determined the mode of procurement as Negotiated Procurement through Small Value Procurement, Section 53.9 of the Updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184;

WHEREAS, on September 22, 2020 the SBAC-FAPs, sent-out a Request for Quotation (RFQ) to various suppliers and posted the same to the PhilGEPS and CHR Websites;

WHEREAS, on September 24, 2020, during the opening and evaluation of bids, the SBAC-FAPs found that no bidder submitted bid proposals for the subject procurement;

WHEREAS, in view of the foregoing, the SBAC-FAPs recommends for a failure of bidding pursuant to Section 35.1 of the Updated 2016 Revised IRR of RA 9184 which provides "The BAC shall declare the bidding a failure when: a) No bids are received." Further, the SBAC-FAPs recommends the re-bidding of the subject procurement project;

NOW, THEREFORE, for and in consideration of the foregoing premises, the SBAC-FAPs hereby resolves to DECLARE A FAILURE OF BIDDING pursuant to Section 35.1 (a) of the Updated Revised Implementing Rules and Regulations (IRR) of Republic Act No.9184. Further, the SBAC-FAPs hereby RECOMMENDS THE RE-BIDDING of the subject procurement project pursuant to Section 35.3 of the Revised IRR of RA 9184.
