RESOLUTION NO. 11-237 Series of 2020

RECOMMENDING A FAILURE OF BIDDING FOR THE PROCUREMENT OF THE SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION MATERIALS PURSUANT TO SECTION 35.1 (C) OF THE UPDATED 2016 REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) 9184

WHEREAS, the Commission on Human Rights (CHR), through the General Administration Office – General Services Division (GAO-GSD) intends to procure Supply and Delivery of Various Construction Materials with an Approved Budget for the Contract (ABC) of Five Hundred Fifty-Six Thousand Pesos (PhP556,000.00);

WHEREAS, said procurement project shall be sourced from the 2020 budget of CHR pursuant to the CHR Annual Procurement Plan (APP) for CY 2020;

WHEREAS, the Bids and Awards Committee for Goods and Services (BAC-GS) determined the mode of procurement as Negotiated Procurement through Small Value Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act (RA) No. 9184;

WHEREAS, in compliance with the requirement of advertisement and posting of procurement opportunities as stated in annex "H" of the 2016 revised IRR of RA 9184 entitled "Consolidated Guidelines for the Alternative Methods of Procurement", the BAC-GS through the Secretariat, posted the Request for Quotation (RFQ) in the PhilGEPS website on November 14, 2020. The same was simultaneously sent out to three (3) suppliers of known qualifications, namely: (1) Luzon Sales Co. Inc.; (2) MZR Builders; and (3) Builtrade Construction Supply;

WHEREAS, MZR Builders and Up-Town Industrial Sales, Inc. submitted their bid proposals before the scheduled deadline on 5:00pm, November 18, 2020;

WHEREAS, the evaluation conducted by the end-user revealed that both submitted bid proposals failed to comply with some of the requirements/specifications, to wit:

WHEREAS, in view of the foregoing, the BAC-GS recommends failure of bidding pursuant to Section 35.1 (c) of the Updated 2016 Revised IRR of RA 9184 which provides that, "The BAC shall declare the bidding a failure when – All bids fail to comply with the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation";

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-GS hereby resolves as it hereby resolved to **DECLARE A FAILURE OF BIDDING** pursuant to Section 35.1 (c) of the Updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No.9184 which provides that "The BAC shall declare the bidding a failure when – All bids fail to comply with all the bid requirements of fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"; and **RECOMMEND THE RE-BIDDING** of the subject procurement project pursuant to Section 35.3 of the Revised IRR of RA 9184.
