RESOLUTION No. 11-228 Series of 2020

**RECOMMENDING THE CANCELLATION OF THE PROCUREMENT PROCESS THROUGH
SECTION 41 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF
REPUBLIC ACT NO. 9184 FOR THE PROCUREMENT OF THE SUPPLY AND DELIVERY OF
VARIOUS ELECTRICAL MATERIALS**

WHEREAS, the Commission on Human Rights (CHR), through the General Administration Office – General Services Division (GAO-GSD), intends to procure Supply and Delivery of Various Electrical Materials with an Approved Budget for the Contract (ABC) of Five Hundred Fifty Thousand Pesos (PhP550,000.00);

WHEREAS, said procurement project shall be sourced from the 2020 funds of the General Administration Office (GAO) pursuant to the CHR Annual Procurement Plan (APP) for CY 2020;

WHEREAS, the Bids and Awards Committee for Goods and Services (BAC-GS) determined the mode of procurement as Negotiated Procurement through Small Value Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on November 11, 2020, the BAC-GS, through the Secretariat, simultaneously posted the Request for Quotation (RFQ) in the PhilGEPS website and sent out to the following prospective bidders of known qualifications, namely: (1) MZR Builders; (2) Luzon Sales Co. Inc.; (3) Builtrade, and (4) Florida Home Builders;

WHEREAS, on November 17, 2020, the BAC Secretariat forwarded the received bid proposal to the end-user for evaluation which in turn submitted the evaluation result on November 25, 2020;

WHEREAS, the BAC-GS in its meeting on December 3, 2020 reviewed the evaluation result and determined the non-inclusion of a significant item in the report which is deemed to be vital to complete the evaluation as part of the procurement process;

WHEREAS, in view of the foregoing, the BAC-GS unanimously declared a cancellation of the procurement process pursuant to Section 41 of the Revised IRR of RA 9184;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-GS hereby resolves as it hereby resolved to **RECOMMEND** the **CANCELLATION OF THE PROCUREMENT PROCESS** pursuant to Section 41 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 *"The HOPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract . . . for the Procurement of Supply and Delivery of Various Electrical Materials.*


