RESOLUTION NO. 09-183 Series of 2020

## RECOMMENDING THE FAILURE OF BIDDING THROUGH SECTION 35.1 OF THE UPDATED 2016 REVISED IRR OF RA 9184 FOR THE SUPPLY AND DELIVERY OF AIR-COOLER

WHEREAS, the Commission on Human Rights (CHR), through the GAO-GSD will procure the Supply and Delivery of Air-Cooler with an Approved Budget for the Contract (ABC) of Two Hundred Forty Thousand Pesos (PhP 240,000.00);

WHEREAS, said procurement project shall be sourced from the 2020 GOJUST Fund pursuant to the CHR Annual Procurement Plan (APP) for CY 2020;

WHEREAS, the Bids and Awards Committee for determined the mode of procurement as Negotiated Procurement through Small Value Procurement, Section 53.9 of the Updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184;

WHEREAS, on September 22, 2020 SBAC-FAPs, sent-out a Request for Quotation (RFQ) to various suppliers and the same was posted to the PhilGEPS and CHR websites;

**WHEREAS**, on September 24, 2020 during the opening and evaluation of bids, the SBAC-FAPs found that only the following bidder submitted a bid proposal for the subject procurement:

1. The Value Systems Phils. Inc.;
