TERMS & CONDITIONS:

- 1. Interested bidder/s are encouraged to use the attached format of Quotation which may be printed in the company letterhead;
- Quotation shall be submitted together with a copy of the following documentary requirements on or before the scheduled deadline of submission as stated in the RFQ. Late submission shall not be accepted:
 - a. 2023 Business / Mayor's Permit
 - b. PhilGEPS Registration
 - c. Brochure, if any (supporting document to your quotation)

The winning bidder will also be required to submit the Omnibus Sworn Statement prior to award of contract.

- The Approved Budget for the Contract (ABC) is the ceiling price. Quotation/s exceeding the ABC shall be disqualified pursuant to Section 31.0 of the 2016 IRR of R.A 9184;
- Failure to comply with <u>any</u> of the technical specifications / requirements will disqualify the quotation;
- 5. Price quotations shall be in Philippine currency, inclusive of all government taxes, duties and levies;
- 6. Price validity period shall be minimum of Sixty (60) days from the date of bid submission;
- 7. Winning bidder will be determined to have submitted the Lowest Calculated Responsive Bid (LCRB). In case of tie, the CHR shall apply the tie-breaking method of "toss a coin" through online coin flipper;
- Payment shall be made through Land Bank of the Philippines' LDDAP-ADA / Bank Transfer facility
 within fifteen (15) calendar days after the complete delivery and submission of the required
 documents. For other banking institution, corresponding bank transfer fee shall be charged against
 the creditor's account.
