## **CHR-NCR Procurement through SVP**

Terms and Conditions

- 1. Interested bidder(s) are required to use the attached prescribed format of Quotation, which may be printed in the company letterhead.
- 2. Quotation shall be submitted together with a copy of the following documentary requirements on or before the scheduled deadline of submission as stated in the RFQ. Late submission shall not be accepted:
  - a. 2025 Business/Mayor's Permit;
  - b. Updated Proof of PHILGEPS Registration; and
  - c. Brochure, if any (supporting document to your quotation).
- 3. The winning bidder may also be required to submit the following documents prior to award of contract, as may be necessary:
  - d. Omnibus Sworn Statement; and
  - e. Latest Income Tax Return.
- 4. The Approved Budget for the Contract (ABC) is the ceiling price. Total financial bid exceeding the ABC shall be disqualified pursuant to Section 31.C of the 2016 IRR of Republic Act No. 9184, as provided under Section 113 (Transitory Provision) of Republic Act No. 12009 (Government Procurement Reform Act).
- 5. Failure to comply with **any** of the technical specifications/ requirements will disqualify the quotation.
- 6. Bidders shall verify and finalize the prices of items and computations made on all bidding documents **before** submission to the CHR-NCR BAC Secretariat. Request for corrections on the bidding documents after their submission to the Secretariat, on account of the mistake and/or negligence of the bidder(s), will automatically result in the disqualification of the said bidder(s) from the bidding process.
- 7. Price quotations shall be in Philippine currency, inclusive of all government taxes, duties, and levies.
- 8. Price validity period shall be minimum of Sixty (60) days from the date of bid submission.
- 9. Winning bidder will be determined to have submitted the Lowest Calculated Responsive Bid (LCRB) or Single Calculated Responsive Bid (SCRB), as the case may be. In case of tie, CHR-NCR shall apply the tie-breaking method of "toss coin" through online coin flipper.
- 10. Payment shall be made through Land Bank of the Philippines' LDDAP-ADA/ Bank Transfer facility within fifteen (15) calendar days after the complete delivery and submission of the required documents. For other banking institutions, corresponding bank transfer fee shall be charged against the creditor's account.
- 11. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. The CHR-NCR may rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
